According to accrual basis, as a result of previous years, the Company recognised the value of granted discount in the amount of net PLN 284,552.03 less assets due to deferred income tax in the amount of PLN 54,064.89.

C.13. Adjustments due to errors

In the financial statement for nine months of 2015, the Company did not recognise the results of errors committed in previous years.
