Subject: Turnover threshold exceeded with AB SA.

Legal basis: § 5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

Report content:

The Management Board of OPTeam S.A. (the Company) announces that the accrued turnover with AB SA with its seat in Wrocław at ul. Kościerzyńska 32 has exceeded the material amount threshold. The total turnover as of the date of this report amounts to net PLN 2,376,732.50 (two million three hundred seventy six thousand seven hundred and thirty two zlotys fifty grosz).

The Company discloses that the highest amount among the transactions making up the above total turnover with AB SA can be found in the order of 28.01.2013, wherein the Company acted as the ordering party and AB SA as the supplier. Under the order, the Company purchased IT equipment to the total net value of PLN 787,370.23 (seven hundred eighty seven thousand three hundred and seventy zlotys twenty three grosz). The terms of the order were typical of such transactions.

The criterion for recognising the accumulated amount of transactions with AB SA as material is the fact that the total value as of the report date exceeds 10% of the Company's equity according to the balance sheet published in the interim report for Q3 2012.
