Subject: Accumulated turnover with Max Computers Sp. z o.o.

Legal basis: §5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

Report content:

The Management Board of OPTeam SA (the Company) announces that the turnover with Max Computers Sp. z o.o. with its seat in Wrocław at Al. Poprzeczna 82 (Max Computers Sp. z o.o.) has exceeded the material amount threshold. The total value of accrued turnover as of the day of submitting this report amounts to: PLN 3,187,732.00 (three million one hundred eighty seven thousand seven hundred thirty two zlotys zero grosz).

The highest-value transaction out of the presented above accrued turnover with Max Computers Sp. z o.o. was the purchase order fulfilled on 28.04.2016, in which the Company acted as the Ordering Party, and Max Computers Sp. z o.o. as the Supplier. The subject matter of the order was the purchase of IT hardware of the total amounting to net: PLN 1,098,188.00 (one million ninety eight hundred thousand one hundred eighty eight zlotys zero grosz) by the Company. The conditions of the transaction were typical of this type of order.

The criterion assumed for recognizing accumulated turnover as material is the parameter of 10% of the Company's equity according to the balance sheet for 2015.
