In the reporting period there were no significant events other than those described herein.

C.24. Seasonality or circularity of the Company's operations in the interim period

Like most companies in the IT sector, the sales of OPTeam S.A. are subject to seasonal fluctuations. Sales are usually at their highest in the fourth quarter of the year, and at their lowest in the first quarter. The seasonality effect as well as certain irregularity of revenues may lead to periodic disruptions of the financial performance.

C.25. The Management's position on the feasibility of realising the published performance forecasts for the given year, in light of results presented in the semi-annual report compared to forecast results.

OPTeam S.A. did not publish forecasts for 2013.

The case is pending. The next hearing was scheduled for 20 February 2014. At this stage of the proceedings, the Company sees no need to establish a provision for liabilities. The Management Board of OPTeam S.A., taking into account the progress made in the negotiations with eService, does not rule out the possibility that the pending proceedings might be settled amicably.

C.30. Dividends paid out and proposed to be paid out

Under resolution no 7/2013 of the Ordinary General Meeting of Shareholders of OPTeam S.A. on 14 June 2013 regarding distribution of profit of OPTeam S.A. for the business year 2012, the amount of PLN 584,000.00, i.e. PLN 0.08 (eight grosz) per share was designated for dividend payment, The Ordinary General Meeting of OPTeam S.A. determined the following dates related to the dividend payment from the profit for the business year 2012: the date of record – on 28 June 2013, and the date of payment – on 12 July 2013.

On 12 July 2013, the dividend was paid out to shareholders to a total of PLN 583 973.28. The remaining amount of dividend that was not paid out, amounting to PLN 26.72, is associated with the treasury stock of OPTeam S.A. and has remained in the Company as undistributed profit.
