Subject: Turnover threshold exceeded with the University of Rzeszów.

Current report no: 28/2013

Legal basis: § 5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

Report content:

The Management Board of OPTeam SA (the Company) discloses that the accumulated turnover with the University of Rzeszów with its seat in Rzeszów 35-959, at ul. Rejtana 16c (University of Rzeszów) has exceeded the material amount threshold. The total turnover as of the date of this report amounts to net PLN 2,535,110.00 (two million five hundred thirty five thousand one hundred and ten zlotys zero grosz).

The Company discloses that the highest amount among the transactions making up the above total turnover with the University of Rzeszów can be found in the contract dated 12.02.2013, whereunder the Company is to expand the network infrastructure of the University of Rzeszów at the Research & Teaching Complex of the Microelectronics and Nanotechnology Centre and the University Centre for Innovation and Knowledge Transfer on Technology and Natural Sciences. The contract amounts to net PLN 2,036,419.00 (two million thirty six thousand four hundred and nineteen zlotys zero grosz). The contract is to be executed within 45 days from the signing date.

The Contractor shall be obliged to pay contractual penalties to the Ordering Party amounting to 10% of the net contract total in the event of the Contractor or Ordering Party withdrawing from the contract for reasons attributable to the Contractor. If the damage exceeds the amount of penalties, the Ordering Party may pursue a claim for supplementary damages up to the amount of actual loss, in line with the provisions of the Civil Code.

The remaining contractual terms do not differ from the typical provisions of such transactions.

The criterion assumed for recognising the accumulated amount of transactions with the University of Rzeszów as material is the fact that their total value as of the report date exceeds 10% of the Company's equity according to the balance sheet published in the interim report for Q1 of 2013.
