Subject: Turnover threshold exceeded with COMP SA.

Current report no: 44/2012

**Legal basis:** § 5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

## **Report content:**

The Management Board of OPTeam SA (the Company) discloses that on 20.12.2012 the turnover threshold with COMP SA Oddział Nowy Sącz – NOVITUS Centrum Technologii Sprzedaży

with its seat in Nowy Sącz at ul. Nawojowska 118 (hereinafter: COMP SA) was exceeded. As at the report's publishing date, total accumulated turnover threshold with COMP SA amounts to PLN 2,120,791.84 (two million one hundred twenty thousand seven hundred ninety one zloties eighty four groszys). The Company discloses that in the total accumulated turnover with COMP SA the highest amount was to be found in the order dated 23.12.2011 for the supply of IT equipment to the Company totaling PLN 53,463.20 net (fifty three thousand four hundred sixty three zloties and twenty groszys ). The provisions of the order are typical for such transactions.

The criterion assumed for determining that the accumulated amount of the transactions with COMP SA as material is the fact that their total value as of the report's date exceeds 10% of the Company's equity according to the balance sheet published in the interim report for Q3 2012.
