B. Introduction to the financial statement for 2019 of OPTeam S.A.

B.1. Identification data of the company

OPTeam Spółka Akcyjna with its seat in Tajęcina 113 near Rzeszów, hereinafter referred to as the Company. OPTeam has been in operation since 1988, initially under the name COMFORT Sp. z o.o., and after 1992 as OPTIMUS-COMFORT Sp. z o.o. In its current legal form, the Company has been in operation since 5.05.2003. Since 11 October 2010, the Company's shares are listed on the Warsaw Stock Exchange.

OPTeam S.A. is entered into the National Court Register of Domestic Entrepreneurs at number 000160492 kept by the Regional Court in Rzeszów, 12th Commercial Division of the National Court Register. The company holds the statistical number REGON 008033000 and tax ID number NIP 813 03 34 531.

OPTeam S.A. runs its business within the Mielec SEZ pursuant to the Licence of the Industrial Development Agency no 149/ARP/2008 of 18 September 2008

The Company's core business includes:

- - software-related activities, including: systems analysis, development and programming,
- consulting services related to information technology,
- activities related to managing IT equipment,
- other services related to information and computer technologies,
- - data processing, management of Internet sites (hosting) and similar activities
- - wholesale of computers, fiscal devices, peripheral devices and software,
- - installation of electrical systems and other utilities,
- - repair and maintenance of computers and peripheral devices, telecommunications equipment,
- - HR outsourcing
- - non-school education.

B.2. Life of the Company

OPTeam S.A. was established to continue until terminated.

B.3. Periods covered in the financial statement and comparable figures

This financial statement covers the period of 12 months ending 31 December 2019 and contains comparable data for the period of 12 months ending 31 December 2018.

This report has been drawn up in compliance with International Financial Reporting Standards (IFRS) as approved by the European Union for one-year periods beginning on 1 January 2019.

B.8. Subsidiaries

OPTeam acquired 70% of shares in the newly created technological company under the name LLCD Sp. z o.o. with its registered office in Tajęcina, which was entered in the Register of Entrepreneurs of the National Court Register on January 21, 2019 under the number 0000768767.

At the end of the preceding year the Issuer did not have subsidiaries.

B.9. Consolidated financial statement

OPTeam S.A. does not draw up consolidated financial statements. The financial data of the created subsidiary (LLCD Sp.z o.o.) is irrelevant to the fulfillment of the obligation to report the property, the financial situation and the financial result of the Company fairly and clearly.

B.10. Company consolidation

In the course of 2019, no changes took place in the structure of the Issuer's business, nor were there any mergers, acquisitions, disposals of subsidiaries.

B.11. Going concern assumption

The financial statement was drawn up on the assumption that the Company will remain a going concern for no less than 12 months after 31 December 2019. There are no circumstances indicating any threats to continuing operations by the Company.

B.12. Principles adopted when drawing up the report and statement of compliance

Statement of compliance with IFRS

This interim condensed financial statement was drawn up in compliance with the requirements of *International Financial Accounting Standards* and the IFRS as approved by the European Union ("EU") for financial statements that cover the accounting year starting on 1st January 2019.

These International Standards include standards and interpretations approved by the International Accounting Standards Board ("IASB") and the International Financial Reporting Interpretation Committee ("IFRIC").

The interim condensed financial statement for the period of twelve months ending 31 December 2019 was drawn up in compliance with the requirements of *Accounting Standard 1 "Presentation of Financial Statements*", which was ratified by the European Union, and according to other applicable regulations.

The scope of the Financial Report complies with the Ordinance of the Minister of Finance of 29 March 2018 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state (consolidated text Journal of Laws No of 2018, item 757) and covers a one-year

period beginning on 1 January 2019 and ending on 31 December 2019, as well as the comparable period beginning on 1 January 2018 and ending on 31 December 2018.
