The Ordinary General Meeting of OPTeam S.A. with its seat in Tajęcina ("**Company**"), acting pursuant to Art. 310 in connection with Art. 431 and 433 § 2 of the Act of 15 September 2000, Code of commercial partnerships and companies ("**CCPC**") and Art. 26 item 5 of the Company's Articles of Association resolves to:

§1

Increase the Company's authorised capital by no less than PLN 100,000.00 (in words: one hundred thousand zlotys) and no more than PLN 150,000.00 (in words: one hundred fifty thousand zlotys), i.e. up to no less than PLN 830,000.00 (in words: eight hundred thirty thousand zlotys) and no more than PLN 880,000.00 (in words: eight hundred eighty thousand zlotys) through a private placement with the pre-emptive rights waived, by issuing no less than 1,000,000 (in words: one

million) and no more than 1,500,000 (in words: one million five hundred thousand) of ordinary bearer series E shares, at nominal value of PLN 0.10 (in words: ten grosz) ("Series E Shares").

- 2. The final amount of authorised capital and the number of Series E Shares shall be determined by the Management Board pursuant to the provisions of Art. 310 of the CCPC.
- 3. Pre-emptive rights to taking up Series E Shares by the current shareholders shall be waived, having adopted the opinion of the Management Board justifying the waiver of pre-emptive rights pursuant to the provisions of Art. 433 § 2 of the CCPC. The opinion of the Management Board is enclosed with this Resolution.
- 4. The Management Board shall be authorised, with the consent of the Supervisory Board, to specify the issue price of Series E Shares, which can be no less than PLN 10 (in words: ten zlotys). The Management Board shall be authorised to select the investors to which the share offering will be addressed.
- 5. Series E Share Subscription Agreements will be concluded within 6 (in words: six) months of passing the resolution.
- 6. The Management Board shall be authorised to conclude an agreement with the National Depository for Securities (KDPW), regarding the registration and dematerialisation of Series E Shares.

Following capital increase through the issue of Series E Shares, the Articles of Association of OPTeam S.A. shall be amended in such a way that Article 8 section 1 shall receive the following wording:

"1. The Company's authorised capital amounts to no less than PLN 830,000 (eight hundred and thirty thousand zlotys) and no more than PLN 880,000 (eight hundred and eighty thousand zlotys) and is divided into:

1) 5,000,000 (five million) series A bearer shares at nominal value of PLN 0.10 (ten grosz) each, numbered 1 through 5,000,000

2) 500,000 (five hundred thousand) series B bearer shares at nominal value of PLN 0.10 (ten grosz) each, numbered 1 through 500,000

3) 800,000 (eight hundred thousand) series C bearer shares at nominal value of PLN 0.10 (ten grosz) each, numbered 1 through 800,000

4) 1,000,000 (one million) series D bearer shares at nominal value of PLN 0.10 (ten grosz) each, numbered 1 through 1,000,000

5) no less than 1,000,000 (one million) and no more than 1,500,000 (one million five hundred thousand) series E bearer shares at nominal value of PLN 0.10 (ten grosz) each, numbered 1 through no less than 1,000,000 and no more than 1,500,000."

- 1. The Supervisory Board shall be authorised to determine the consolidated text of the Company's Articles of Association to include the amendments resulting from the provisions of the present resolution.
- 2. The resolution shall be effective immediately.

Opinion of the Management Board of OPTeam Spółka Akcyjna regarding grounds for waiving all of pre-emptive rights to series E shares and approach to determining the issue price of series E shares.

The Management Board of OPTeam S.A. ("Company") hereby submits its opinion regarding the grounds for waiving pre-emptive rights and identifying the approach to determining the issue price.

OPTeam S.A. and Polish ePayment, in which the Company holds a 50% stake in the authorised capital, are developing dynamically. To accelerate growth, it is necessary to raise funds to realise new investments. The purpose of Series E Share Issue is to raise funds for such endeavours as: (i) boosting the Company's growth through acquisitions; (ii) expanding the Company's product range, especially in the education sector (iii) launching mobile and internet payments (iv) supporting the dynamic growth of Polish ePayment in which the Company holds a 50% stake in the authorised capital.

It is the opinion of the Management Board that increasing the authorised capital through a private placement will enable the Company to acquire the funds needed to fulfil the Series E Issue objectives in a shorter time, compared to a public offering with pre-emptive rights intact. Time is of the essence here, as quick results will enable the Company to undertake new challenges and boost growth, which is particularly vital in the IT sector and best meets the Company's interests and needs. The Management Board believes that speedy execution of the investment is in the best interest of the current shareholders, as it should bring about a significant increase in Company value. Bearing the above in mind, there are legitimate grounds for waiving all pre-emptive rights of the shareholders with regard to the Series E Share Issue, which will additionally enable the Company to attract new long-term investors. Series E Shares will be offered in a private placement to investors selected by the Management Board.

To be able to adjust the issue price of Series E Shares flexibly to the current market conditions and the Company's circumstances, the issue price of Series E Shares will be determined by the Management Board with the Supervisory Board's consent. Granting rights to the Management Board and Supervisory Board to determine the issue price of Series E Shares is justified in light of the necessity to adjust the issue price to the demand for the offered Series E Shares and to the situation in financial markets.

Taking into account the above circumstances, the Management Board recommends to the General Meeting of OPTeam S.A. to vote in favour of the resolution regarding increasing the authorised capital with pre-emptive rights of current shareholders waived.
