C.1. General information and scope of activity

OPTeam Spółka Akcyjna with its seat in Tajęcina 113 near Rzeszów, hereinafter referred to as the Company. OPTeam has been in operation since 1988, initially under the name COMFORT Sp. z o.o., and after 1992 as OPTIMUS-COMFORT Sp. z o.o. In its current legal form, the Company has been in operation since 5.05.2003. Since 11 October 2010, the Company's shares are listed on the Warsaw Stock Exchange.

OPTeam S.A. is entered into the National Court Register of Domestic Entrepreneurs at number 000160492 kept by the Regional Court in Rzeszów, 12th Commercial Division of the National Court Register. The company holds the statistical number REGON 008033000 and tax ID number NIP 813 03 34 531.

OPTeam S.A. runs its business within the Mielec SEZ pursuant to the Licence of the Industrial Development Agency no 149/ARP/2008 of 18 September 2008

The Company's core business includes:

- - software-related activities, including: systems analysis, development and programming,
- - consulting services related to information technology,
- - activities related to managing IT equipment,
- other services related to information and computer technologies,
- - data processing, management of Internet sites (hosting) and similar activities
- - wholesale of computers, fiscal devices, peripheral devices and software,
- - installation of electrical systems and other utilities,
- - repair and maintenance of computers and peripheral devices, telecommunications equipment,
- - HR outsourcing
- - non-school education.

C.6. Going concern assumption

The present financial statement was drawn up using the assumption that OPTeam S.A. is a going concern and will remain so into the foreseeable future.

There are no circumstances indicating any threats to continuing operations by the Company in at least next 12 months upon the balance date.

C.7. Principles adopted when drawing up the report

Statement of compliance with IFRS

This interim condensed financial statement was drawn up in compliance with the requirements of *International Financial Accounting Standards* and the IFRS as approved by the European Union ("EU") for financial statements that cover the accounting year starting on 1st January 2019. These International Standards include standards and interpretations approved by the International Accounting Standards Board ("IASB") and the International Financial Reporting Interpretation Committee ("IFRIC").

The interim condensed financial statement for the period of three months ending 31 March 2019 was drawn up in compliance with the requirements of *International Accounting Standard 34 "Interim financial reporting"*, which was ratified by the European Union, and according to other applicable regulations.

Pursuant to the Ordinance of the Minister of Finance of 29 March 2018 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state (Journal of Laws of 2018, item 757) the Company is obliged to publish its financial statement for the period of three months ending on 31 March 2019 which is considered to be the current interim reporting period.

Changes of the accounting principles used

A description of the important accounting policies used by the Company is provided in the financial statements for the year ended December 31, 2019, which was disclosed to the public on March 20, 2020.

This interim financial report drawn up as of and for the period of three months ending 31 March 2020 was drawn up using the same accounting principles as when drawing up the annual financial statement for the business year ending 31 December 2019.

C.8. Changes of presentation

In the quarterly condensed financial statements prepared for the period of 3 months ended on March 31, 2020, there were no changes in the presentation, except for the presentation in the Statement of Profit and Loss in the value of "*Cost of products and services sold*" in comparable data for 2019, which did not include sales costs in the previous year in the amount of PLN 1 170 863.77 and were accounted for in the cost of goods sold and presented under the item "*Cost of products, goods and materials sold*" of the *Profit and loss statements*.

C.9. Identification of factors which, in the issuer's opinion, will affect its performance within a time span of at least one next quarter.

In the opinion of the Management Board of OPTeam S.A. the current financial standing of the Company is stable. The results achieved by OPTeam in the perspective of the next quarter will be influenced by typical factors shaping the operating activity of the Company (existing portfolio of contracts, efficiency of their implementation, potential new contracts, product development, etc.).

Influence of COVID-19 on the Company

As at the date of publication of these financial statements, the Management Board, based on the analysis of risks to date, including in particular those resulting from the prevailing virus pandemic, has concluded that the continuation of the Company's operations for a period of not less than 12 months from March 31, 2020 is not at risk.

The Company monitors the impact of the COVID-19 pandemic on an ongoing basis on the Company's operations, including its future financial position and future financial results. At the time of publication of this report, the Company noted a small impact of the virus on its financial position and economic results, but only a significant impact on the organizational aspect of the Company's operations.

As a consequence of the entry into force in Poland of the Act of March 2, 2020 on special solutions related to the prevention, prevention and eradication of COVID-19, other infectious diseases and crisis situations caused by them (Journal of Laws of 2020, item 374) and because of concern for the employees of the Company and its clients, the Company has taken steps to provide the so-called remote work by most employees to ensure business continuity and continue to provide IT services to our clients. At the time of publication of this report, the Company operates on an ongoing basis and fulfills its contractual obligations.

OPTeam S.A. has sufficient financial resources to continue its operations, including settlement of current liabilities. However, the Company cannot exclude that in the event of a prolonged pandemic situation and its negative impact on the economy, this situation may have an adverse effect on the Company's functioning or financial results - however, it is currently not possible to determine to what extent and scale it could it will happen. At the time of publication of this report, there are no grounds to expect that the situation caused by COVID-19 could have a significant impact on the Company. If it is determined that the Company, operations need to be adapted to new market conditions, the Management Board will take appropriate action.
