Subject: Supplementary information to current report no 2/2014 dated 10.01.2014 – notification under Art. 69 section 1 Public Offering Act.

Legal basis: Art. 70 item 1 of the Public Offering Act – acquisition or disposal of a material equity stake and § 3 section 2 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim disclosures submitted by the issuers of securities, and on conditions of considering as equivalent the disclosures required by law of a non-member state.

Report content:

The Management Board of OPTeam SA ("Company", "Issuer") discloses that a letter was received on 16 January 2014 from the shareholder Idea Towarzystwo Funduszy Inwestycyjnych SA ("Idea") which stated that the notification that Idea had come to hold the stake of 7.18% of votes at the General Meeting of the Company, according to which the Issuer prepared and disclosed current report no 2/2014 on 10.01.2014, by mistake did not include the date of acquisition of the Issuer's shares. In light of the above, the Issuer's Management Board further to report no 2/2013 dated 10.01.2014 announces that the transaction during which Idea acquired the Issuer's shares and consequently reached the stake of 7.18% of votes at the Issuer's General Meeting, took place on 20.12.2013 (Idea 20 FIZ Aktywów Niepublicznych – Closed-Ended Investment Fund Non-Public Assets), of which Idea was notified on 02.01.2014.
