Subject: Turnover threshold exceeded with Veracomp SA.

Legal basis: §5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

Report content:

The Management Board of OPTeam SA (the Company) announces that turnover with Veracomp SA company with its seat in Kraków, ul. Zawila 61 (Veracomp SA) has exceeded the material amount threshold. The total net value of the accrued turnover as of the date of submission of the report is: PLN 5,374,583.13 (five million three hundred seventy four thousand five hundred eighty three zlotys thirteen grosz). The highest-value transaction out of the total turnover with Veracomp SA was a purchase order, in which the Company acted as the Ordering Party, and Veracomp as the Supplier. Under the order, the Company purchased IT equipment of a total net value of: PLN 3,178,781.50 (three million one hundred seventy eight thousand seven hundred eighty one zlotys fifty grosz). The terms of the transaction were typical of such orders.

The criterion assumed for recognising the accumulated turnover as material is the parameter of 10% of the Company's equity according to the balance sheet published as of 31 Dec 2013.
