Subject: Material contract concluded with Opole University of Technology – turnover threshold exceeded.

Current report no: 34/2013

Legal basis: § 5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

Report content:

The Management Board of OPTeam SA (the Company) announces that a material contract was concluded and turnover threshold based on the accrued value of contracts exceeded with the Opole University of Technology [Politechnika Opolska] with its seat at ul. Prószkowska 76, 45-758 Opole. The total turnover with the Opole University of Technology as of the date of this report amounts to net PLN 4,113,453.79 (four million one hundred thirteen thousand four hundred and fifty three zlotys 79/100 grosz).

The Company discloses that among the transactions making up the above total turnover with the Opole University of Technology, the highest amount is to be found in the contract dated 26.08.2013. In the contract the Company acts as the Contractor, and the Opole University of Technology as the User. Under the contract, the Contractor is to deliver, develop and implement an Integrated Enterprise System (ES). The contract is worth net PLN 4,039,923.79 (four million thirty nine thousand nine hundred and twenty three zlotys 79/100 grosz).

The following contractual penalties are stipulated: the User has the right to charge penalties for each of delay on the Contractor's part in performance of a stage provided for in the contract for reasons independent of the User, amounting to 0.5% of the remuneration payable for the given stage. Penalties for the above are capped at 30% of remuneration for the given stage. If either Party withdraws from the contract for reasons attributable to the Contractor, the Contractor shall pay the User a contractual penalty amounting to 15% of the contract total, and if either Party withdraws from the contract for reasons attributable to the User, the User shall pay the Contractor a contractual penalty amounting to 15% of the contract total. The User shall be entitled to pursue supplementary compensation in excess of the stipulated contractual penalties. The remaining contractual terms do not differ from the typical provisions of such contracts.

The criterion assumed for recognising the accumulated amount of transactions with the Opole University of Technology as material is the fact that their total value as of the report date exceeds 10% of the Company's equity according to the balance sheet published in the interim report for Q1 of 2013.
