Subject: Accumulated turnover with Comarch SA – exceeding the threshold of 10% of equity.

Current report no: 30/2012

Legal basis: § 5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

Report content:

The Management Board of OPTeam SA(the Company) announces to the public that the turnover based on the value of its transactions with Comarch SA with its seat in Cracow, Aleja Jana Pawła II 39A, has exceeded the material amount threshold. The total accumulated turnover with this firm as of the date of this report amounts to net PLN 1,971,297.11.

At the same time, the Company discloses that among the contracts making up the above-mentioned total turnover with Comarch SA, the highest amount is to be found in the transaction dated 30.05.2012 whereby the Company bought an enterprise management software licence in connection with an implementation project for a business partner. The transaction amounted to net PLN 102,459.80, and the contractual terms stipulated did not differ from the typical provisions of such contracts.

The criterion assumed for recognising the accumulated amount of transactions with Comarch SA as material is the fact that their total value as of the report date exceeds 10% of the Company's equity according to the balance sheet published in the interim report for Q1 of 2012.
