## **Report content:**

The Management Board of OPTeam SA is releasing an amendment to the current report no 9/2013 published on 18 April 2013. The amendment concerns information about the financial plans of the Centre of Electronic Clearance Polish ePayment with its seat in Rzeszów (hereinafter: Polish ePayment), in which OPTeam SA holds a 50% share.
