RESOLUTIONS PASSED BY THE ORDINARY GENERAL MEETING OF SHAREHOLDERS of OPTeam SA with its seat in Tajęcina convened on 11 May 2016

Resolution no 1/2016 of the Ordinary General Meeting of Shareholders of OPTeam Spółka Akcyjna with its seat in Tajęcina of 11 May 2016

Acting pursuant to Art. 409 § 1 of the Code of commercial partnerships and companies and § 3 section 1 of the Rules of the General Meeting, the Ordinary General Meeting of OPTeam S.A. with its seat in Tajęcina resolves what follows:
