Subject: Accumulated turnover with Europejski Fundusz Leasingowy SA

Legal basis: §5 section 3 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

Report content:

The Management Board of OPTeam SA (the Company) announces that the turnover with Europejski Fundusz Leasingowy (European Leasing Fund SA; hereinafter EFL SA) with its seat at ul.Orląt Lwowskich 1, 53-605 Wrocław has exceeded the material amount threshold. The total value of turnover as of the date of submitting this report amounts to: PLN 2,885,032.09 (two million eight hundred eighty five thousand thirty two zlotys 09/100 grosz).

The highest-value transaction out of the presented above accumulated turnover with EFL SA was licenses sale transaction of 05.02.2016, in which the Company acted as the Seller and EFL SA as the Buyer. The total net value of transaction is: PLN 600,000.00 (in words: six hundred thousand zlotys, 00/110 grosz). The conditions of the transaction were typical of such kind of execution.

The criterion assumed for recognising the accumulated turnover as material is the parameter of 10% of the Company's equity according to the balance sheet for the third quarter of 2015.
